THE APPROPRIATION (1992) LAW, 1991
(LAW 22 OF 1991)

**A LAW
TO APPROPRIATE CERTAIN EXPENDITURES
FOR THE SERVICES OF THE FINANCIAL YEAR 1992**

ENACTED by the Legislature of the Cayman Islands.

Short Title.

1. This Law may be cited as the Appropriation (1992) Law, 1991.

Expenditure of
\$122,490,986.

2. The Financial Secretary of the Islands may pay a sum not exceeding in the aggregate one hundred and twenty-two million, four hundred and ninety thousand, nine hundred and eighty-six dollars for defraying the several charges and expenses of the Government of the Islands and for other purposes for the period 1st January, 1992, to 31st December, 1992, as set forth in the Schedule to this Law and such sum is hereby charged upon the revenue and funds of the Islands.
